



Company wise Charge Details







03-Oct	RBI	Special Rupee Vostro Account	RBI now allows non-residents holding Special Rupee Vostro Accounts (SRVA) to invest rupee surplus balances in non-convertible debentures, bonds, and commercial papers of Indian companies, under General Route limits, effective immediately, with compliance and reporting by banks.
06-Oct	RBI	Foreign Currency Account by Resident Indian	RBI's Seventh Amendment to FEMA 10(R), 2025 permits Indian exporters to maintain foreign currency accounts abroad or in IFSCs for export proceeds. Funds must be used for imports or repatriated within three months (IFSC) or next month (others).
28-Oct	RBI	Nomination Facility in Deposit Accounts	RBI's 2025 Directions mandate banks to offer and manage nomination facilities for deposit accounts, lockers, and safe custody articles, ensuring faster claim settlement after a customer's death, customer awareness, timely acknowledgements, and uniform compliance effective from November 1, 2025, across all banks.
